

Edmark Reading Program Level 1 License Agreement

PLEASE READ THIS AGREEMENT CAREFULLY BEFORE USING THE PROGRAM. PRO-ED, INC. WILL ONLY LICENSE THE PROGRAM TO YOU IF YOU FIRST ACCEPT THE TERMS OF THIS AGREEMENT. REGARDLESS OF HOW YOU ACQUIRE THE PROGRAM (ELECTRONICALLY, PRELOADED, ON MEDIA OR OTHERWISE), BY USING IT YOU AGREE TO THESE TERMS.

You may not rent, lease, sell, sublicense, assign, distribute or otherwise transfer the PROGRAM except as provided in this Agreement. You may not reverse compile, reverse assemble or translate any part of the PROGRAM, except as specifically permitted by law without the possibility of contractual waiver.

II. COPYRIGHT.

The PROGRAM is owned by PRO-ED, Inc. and is copyrighted and licensed, not sold. You may make one copy of the PROGRAM for backup purposes. You must reproduce the copyright notice(s) on such copy of the PROGRAM.

III. TERM AND TERMINATION.

You may terminate your license to the PROGRAM at any time by destroying all of your copies of the PROGRAM. In addition, PRO-ED, Inc. may terminate your license to the PROGRAM if you fail to comply with all the terms and conditions of this Agreement. Upon termination, you agree to destroy all of your copies of the PROGRAM.

IV. NO WARRANTY.

MAKES NO WARRANTIES OR CONDITIONS EITHER EXPRESS OR IMPLIED, INCLUDING, WITHOUT LIMITATION, THE WARRANTY OF NON-INFRINGEMENT AND THE IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE, REGARDING THE PROGRAM. THE EXCLUSION ALSO APPLIES TO ANY OF PRO-ED, INC.'S SUBCONTRACTORS, SUPPLIERS OR PROGRAM DEVELOPERS (COLLECTIVELY CALLED "SUPPLIERS").

V. LIMITATION OF LIABILITY.

NEITHER PRO-ED, INC. The laws of the country in which you acquired the PROGRAM govern this Agreement, except: (1) in Australia, the laws of the State or Territory in which the transaction is performed govern this Agreement; (2) in Central Europe and Russia, the laws of Austria govern this Agreement; (3) in Estonia, Latvia, and Lithuania, the laws of Finland govern this Agreement; (4) in Canada, the laws of the Province of Ontario govern this Agreement and (5) in the United States and Puerto Rico, and the People's Republic of China, the laws of the State of New York govern this Agreement. You agree to comply with all applicable governmental laws, regulations, orders and rules, including, without limitation, those that relate to the export of the PROGRAM. This Agreement is the complete and exclusive agreement regarding the PROGRAM and replaces any prior oral or written communications between you and PRO-ED, Inc. For a change to be valid, both you and an authorized PRO-ED, Inc. representative must sign it.
